# ALS Subcommittee Meeting Minutes

November 18, 2020

#### **Old Business**

#### **ALS Renewal Requirements**

#### **Protocol Orientation**

The Protocol Orientation finished the first round of beta testing on November 15th with positive reviews. It is in a second round of beta testing, which is scheduled to end on November 29th.

Discussions on possible release dates will begin in December.

The requirements to complete the 2020 State Renewal courses has been pushed back to March 31, 2022. ALS clinicians will have until this date to complete the content.

The three in-person renewal courses have been converted to an additional online format so that they can be completed in either in-person or online.

#### **New business**

#### Educational program access to hospital clinical sites - Robert Muller

- There are widespread issues with paramedic students not being allowed into clinical sites at the hospitals. Some programs do not have any hospital and/or field clinical access or access is limited.
- Rae Oliviera reported that one reason is because hospitals are closed to visitors, which affects clinical rotations.
- Pete Fiackos polled all college programs last week to determine how wide-spread this issue is. There are no updates on how to fix this problem at this time.
- Luis Pinet-Peralta suggested that any program coordinators with problems reach out to their regional administrators to let them know so that the administrators can reach out to the base station hospitals about the situation as well.

#### **Announcements**

#### ALS Clinicians on extension

Anyone who did not recertify by 10/31/2020 was automatically extended to 11/30/2020. MIEMSS will continue to place clinicians on month-to-month extensions for the duration of the state of emergency. Additional 6-month extensions are no longer available.

A memo was sent to all clinicians affected. This memo is attached.

- Encourage everyone who can recertify to recertify. They do not need to wait until the state of emergency is over.
- Anyone who planned to let their license lapse in April 2020 due to retiring, leaving the field, etc., is still on an extension. All non-renewed licenses will remain valid until 30 days after the state of emergency is over.

  Those not planning to renew should submit a request to surrender.

The next ALS Subcommittee meeting will be held on Wednesday, January 20, 2021.

RE: 2020 State Content Courses for ALS Renewals (**UPDATE-11/2/2020**)

Every two years, QA/QI trends across the state are evaluated in an effort to improve EMS clinician knowledge and skills. Using this information, the ALS Committee has developed mandatory training for all advanced life support (ALS) clinicians. This continuing education must be completed by March 31, 2022. The deadline for all ALS clinicians (CRTs and Paramedics) has been extended due COVID-19.

A total of fifteen (15) hours of continuing education are required to meet the National Registry State/Local recertification requirement for ALS clinicians. In Maryland, ten (10) of these hours must consist of state-level mandatory training. All ten hours are now available in online format. The final three courses below may be taken in-person or online.

The remaining five (5) hours of State/Local continuing education should be completed according to EMS operational program requirements.

Online Courses (located in the online training center):

- Pediatric Seizures (1 hour)
- Anaphylaxis (0.5 hour)
- EMS Health & Wellness (1 hour)
- Patient Technology (2 hours)
- Annual Protocol Updates (1.5 hours)
- Behavioral Health (1 hour)
- Prehospital Sepsis Management (1 hour) in-person or online
- Cultural Competency: Transgender Patients (1 hour) in-person or online
- End-tidal Capnography for Differential Diagnosis (1 hour) in-person or online

The online courses are now available in the MIEMSS Online Training Center (<a href="www.emsonlinetraining.org">www.emsonlinetraining.org</a>). In addition, the train-the-trainer module has also been posted in the Online Training Center for those EMS instructors who wish to be designated by their EMS Operational Program to teach in-person courses. Guidance on obtaining instructor access to the in-person course content is attached.

# <u>Information and Frequently Asked Questions Regarding Expiration of EMS Licenses and</u> Certifications

Pursuant to Governor Hogan's Order Number 20-06-19-01, dated June 19, 2020, the expiration date of all licenses and certifications issued by the State of Maryland is extended until the 30<sup>th</sup> day after the date the state of emergency is terminated and the catastrophic health emergency is rescinded.

All EMS clinicians are encouraged to renew prior to their expiration date. Further, EMS clinicians are expected to continue to meet the standards for professional conduct which includes completion of continuing education and other requirements for renewal consistent with their current license or certification cycle.

MIEMSS is issuing this FAQ to clarify the impact of the Governor's order on EMS licenses and certifications and when MIEMSS may grant an extension under COMAR 30.02.02.07J.

Please note that a license or certification issued after any extension, including the extension under the Governor's order and any extension under COMAR 30.02.02.07J, will be for a term starting from the original expiration date for your current license or certification cycle.

Answers to specific questions regarding how this impacts your EMS license or certification are below.

Q. I am a paramedic or CRT and the original expiration date for my current license cycle is April 30, 2020. When will my license expire?

A. If you don't renew, or request an extension, your license will expire 30 days after the state of emergency ends. In the meantime, your license will be extended on a month-to-month basis. After you complete the requirements for renewal, your new license will expire April 30, 2022. Q. I am a paramedic or CRT and the original expiration date for my current license cycle is April 30, 2020. May I request an extension under COMAR 30.02.02.07J?

A. Yes, if you submit your request before October 31, 2020, you may receive a 6-month extension under COMAR 30.02.02.07J. Your license will then expire April 30, 2021 or 30 days after the end of the State of Emergency, whichever is later. Note that upon renewal, the new license will expire April 30, 2022.

Q. I am an EMT, EMR or EMD and the original expiration date for my current certification cycle is December 31, 2019. When does my certification expire?

A. If you don't renew, your certification will expire 30 days after the state of emergency ends or December 31, 2020, whichever is later. In the meantime, your certification will be extended on a month-to-month basis. After you complete the requirements for renewal, your new certification will expire December 31, 2022.

Q. I am an EMT, EMR, or EMD and the original expiration date for my current certification cycle is December 31, 2019. May I request an extension under COMAR 30.02.02.07J?

A. No. Your certification will expire 30 days after the state of emergency ends or December 31, 2020, whichever is later.

Q. I am an EMT, EMR or EMD and the original expiration date for my current certification cycle is June 30, 2020. When does my certification expire?

A. If you don't renew or request an extension, your certification will expire 30 days after the state of emergency ends or December 31, 2020, whichever is later. In the meantime, your certification will be extended on a month-to-month basis. After you complete the requirements for renewal, your new certification will expire June 30, 2023.

Q. I am an EMT, EMR or EMD and the original expiration date for my current certification cycle is June 30, 2020. May I request an extension under COMAR 30.02.02.07J?
