The Maryland RISK WATCH team has four goals at Convention:

- 1. To provide young children and school age children hands on education experiences to be safer in their homes & communities through both psychomotor skills and new knowledge about high risk injuries.
- 2. To provide young life safety advocates (tweens, teens and young adults) with a mentored experience and specific lesson plans to work with younger children and their families.
- 3. To empower parents and care providers with knowledge on both the risks and the prevention strategies to keep everyone safer in their home and community (infants through seniors).
- 4. To demonstrate interactive safety displays based upon evidence based and best practices for life safety advocates across Maryland's EMS, Fire & Rescue services.

Maryland Risk Watch Team at the state level will be identifying the current status of the interactive games located in the partnering communities. Some of these resources were distributed 10 years ago and may need to be updated. In the fall there will be new Bike Safety and Medication Safety educational tools available. We will be sending out a inventory survey in August to allow for planning for 2018-2019 resources. Email riskwatch@msfa.org.

Recently Maryland EMSC was able to provide all the Safe Kids Coalitions with a Bike Helmet Display for training and has Smoke Alarm – 10 year battery displays to distribute this fall.

Maryland Safe Kids Updates:

Grants from Safe Kids Worldwide has been received for the following activities / risk area focuses. The majority of the grant award is in materials (banners, games, handouts, logo trinkets) but not monetary awards.

- 1. Safe Kids Day Grant was incorporated into the MSFA Convention activities room and include banners and games. Mini Grant was from Safe Kids Worldwide is completed.
- 2. Medication Safety Grant focused on "OTC" (over the counter) medication safety for preteen and teens has been awarded. With the mini grant funds we will be building table top banner displays for each Safe Kids Coalition / Risk Watch community with the new Infographic (attached to the April Risk Watch update) and medication VS candy identification education tool. Mini Grant was from Safe Kids Worldwide is ongoing through December.
- 3. Water Safety Grant is focused on both pools and open water. Cecil County DES and Peninsula Regional Medical Center are the lead communities. Mini grant funds were spent for displays including: PFDs in all sizes, Water Watcher tags and lanyards, pool safety printed materials and two table top fabric banners. Mini Grant was from Safe Kids Worldwide was completed at the end of August.
- **4. Bike Helmet Safety Grant from Maryland Highway Safety Office:** Recently Maryland EMSC was able to provide all the Safe Kids Coalitions with a Bike Helmet Display for training, A new poster has been designed and will be printed in October. Two short PSAs on Bike Helmet Safety will be created this fall and produced for spring.
- 5. Child Passenger Safety Grant from Maryland Highway Safety Office: is ongoing and just competed a safe travel in Airports display. Another Outdoor Temperature Thermometer will be purchased through this grant for Western Maryland and kept at Meritus Trauma Center in Hagerstown. New Steps for CPS poster just arrived and will be available through the EMSC office.
