

## Maryland Ambulance Safety Leadership Summit

MIEMSS and its partners within the Maryland Ambulance Safety Taskforce hosted an Ambulance Safety Leadership Summit at the Maritime Institute of Technology and Graduate Studies (MIT-AGS). Over 90 attendees met to hear best practices and to discuss several aspects of emergency vehicle safety.

The Task Force on Ambulance Safety is comprised of MIEMSS, the Maryland Fire & Rescue Institute (MFRI), Maryland State Fireman's Association (MSFA), and jurisdictional and commercial ambulance companies. EMS is a transport-based emergency service with practitioners providing a variety of treatment modalities

conducted during patient transportation to hospital and specialty care facilities. While risk factors exist in ambulance safety, Maryland's goal is to create a culture of safety through best practices in screening, training, policies, and procedures.

The MIEMSS Ambulance Safety Task Force Report recommendations include the following:

1. Screen ambulance drivers – Jurisdictions and companies should implement initial and periodic driver screening to identify ambulance drivers whose driving records, excessive risk-taking, or medical conditions may make

them poor candidates for the responsibility of driving an ambulance.

2. Ensure effective initial ambulance driver training and periodic refresher training – Ambulance-specific driving training should be uniformly required by jurisdictions and available for ambulance drivers in Maryland.
3. Increase use of restraints and safety improvements during ambulance operations – Jurisdictions and companies should set, monitor and enforce policies that require the use of seat belts / restraints for the driver, other EMS personnel in the ambulance and the patient being transported.

## NIST and Partners Seek Input on Safer Ambulance Designs

The National Institute of Standards and Technology (NIST) is seeking input from paramedics, emergency medical technicians (EMTs) and other interested parties on the development of new design guidelines for ambulances to reduce the crash risk to emergency workers.

Emergency medical service (EMS) workers riding in the back of ambulances are at high risk of suffering injuries during a crash or a maneuver to avoid a crash if they're not using restraints. However, restraints make it difficult to access and treat patients while in route to a hospital. To meet the challenge of finding a balance between these two demands, NIST, the Department of Homeland Security's Human Factors and Behavioral Sciences Division (DHS HFD) and the National Institute of Occupational Safety and Health (NIOSH) are developing design guidelines for ambulance patient compartments that maximize safety without compromising effectiveness. These guidelines will be used to update current, and enhance emerging, ambulance design criteria, such as National Fire Protection Association (NFPA) 1917, the "Standard for Automotive Ambulances."

To gather input for the guidelines from a broad cross-section of the key stakeholders, EMTs and paramedics, the three agencies are conducting an anonymous web survey until **December 28, 2011**. Insight and opinions from this survey will supplement data previously gathered from focus groups, interviews with individual EMS workers, visits to equipment manufacturers and EMS stations, and "ride-along" experiences aboard on-duty ambulances.

4. Reduce the incidence of excessive ambulance speeds and routine use of “lights and sirens” – Jurisdictions and companies should ensure that response and transport policies reinforce the need for safety as the first priority and should tailor practices to the degree of urgency as determined by patient need.
5. Improve monitoring of ambulance safety issues and enforcement of safety practices – Jurisdictions and companies should develop written policies that foster increased ambulance safety, ensure the availability of accurate data needed for effective monitoring of ambulance safety issues, and include formal review of ambulance crashes and near-misses.
6. Create an ongoing statewide forum for ambulance safety issues – The Ambulance Safety Task Force should continue to promote the advancement of ambulance safety throughout Maryland, monitor trends in ambulance crashes, and provide a forum for addressing future ambulance safety issues common to all jurisdictions and counties, including a review of the updated NFPA 1917.

## NHTSA Announces Safety Defect Investigation

On November 25, the National Highway Traffic Safety Administration (NHTSA) announced a safety defect investigation to determine the risk of fire in Chevy Volt vehicles that have been involved in a crash.

The investigation comes as a result of a Chevy Volt New Car Assessment Program (NCAP) crash test that was intended to test the vehicle’s ability to protect passengers from a side collision. The test, which was held in May 2011, damaged the lithium-ion battery and ruptured the vehicle’s coolant line. A fire that occurred in the vehicle three weeks following the side collision crash test has been linked to the damaged lithium-ion battery.

NHTSA is currently working with the Department of Energy and the Department of Defense to conduct tests of the lithium-ion battery. As of November 18, three tests were conducted that damaged the battery and ruptured the coolant line of the Chevy Volt. Two out of

the three tests resulted in a thermal event, including a fire. The side collision crashes were intended to mimic a real-life crash in which the vehicle collides into a narrow object followed by a rollover.

NHTSA has asserted that Chevy Volt owners who have not been involved in a serious crash have no reason for worry. There are currently no known crashes that have resulted in a fire related to the lithium-ion battery on the roadways.

There is currently no recall of the Chevy Volt or its parts, however, there is potential for the investigation to lead to such a recall. NHTSA is working with the Department of Energy and the National Fire Protection Association to help inform the EMS community of these potential fires.



# Maryland Remembers DUI Victims in 8th Annual Memorial

On December 7, 2011, The Impaired Driving Coalition hosted the 8th annual Maryland Remembers memorial in Annapolis, Md. In a somber ceremony, Maryland families brought pictures and read the names aloud of the loved ones they have lost in the past year as well as previous years to drunk driving. Four candles were lit in the honor of these victims, signifying grief, courage, memory, and love.

In 2010, 177 people fell victim to drunk driving; an act that is entirely preventable. The memorial reminded everyone of the consequences of drunk driving and reassured Marylanders that all steps are being taken to make the 2011 holiday season a safe one. Annually, Maryland roadways see an average of 8,430 impaired driving crashes.

Every year, the memorial is held at a time when DUI crashes are at their highest throughout the country; between Thanksgiving and New Years. The memorial also coincides with National Drunk Driving Prevention Month. Several alternatives to getting behind the wheel after drinking were discussed at the memorial, including the SoberRide and Topsy?Taxi! services.

Among those who spoke at the ceremony was Casey Brooks, the daughter of Late

Corporal Courtney Brooks, who was killed in a hit-and-run by a drunk driver on New Year's Eve 2007. Colonel Marcus Brown, Superintendent for the Maryland State Police, also spoke of the same night, when he was patrolling Interstate 95 and responded to the call after the collision occurred. Colonel Brown expressed his goal to prevent festive 2011 holiday celebrations from turning into fatalities.

Lieutenant Governor Anthony Brown, who is the honorary chairperson on the Impaired Driving Coalition, addressed the current problem facing Maryland; the number of alcohol impaired crashes has not declined at all throughout the past few years; instead, it has increased. Lt. Governor Brown discussed the focused resources that will be in high-risk areas throughout Maryland. This initiative, named Project SOLO, will be enforced in Anne Arundel, Baltimore, Montgomery, and Prince George's counties.

While the numbers are not steadily decreasing just yet, the Maryland State Police and Impaired Driving Coalition have taken steps to start a new trend. Checkpoint Strikeforce is an initiative designed to catch and arrest drunk drivers through sobriety checkpoints, as well as educate the public on the

dangers of drunk driving. In 2010, there were over 22,000 arrests made for DUI in Maryland, averaging 62 arrests per day. The sobriety checkpoints will continue this holiday season, as they are placed in strategic locations where drunk driving is most likely to occur.

On October 1, 2011, a new DUI law was implemented in Maryland. Some of the new components of this law include drivers whose BAC is above 0.15 will have to complete the ignition interlock program or face suspension until the program is completed; Drivers with a second alcohol conviction within five years will have mandatory participation in the interlock program or face suspension; and anyone under 21 who violates their alcohol restriction will have mandatory participation in the interlock program or face suspension. Maryland law enforcement agencies will be vigilant in enforcing the impaired-driving laws during this holiday season.

With the 2011 holiday season in full-swing, it is important to remember the lives lost due to preventable acts like drunk driving, and stay safe by making plans ahead of time if you are planning to drink.

## Be Prepared: Get Your Seasonal Flu Shot Now

MIEMSS recommends all emergency services providers get an annual influenza vaccination. The Centers for Disease Control and Prevention (CDC) recommends that everyone six months of age and older get the flu vaccine - even if they were vaccinated last year - since immunity from vaccination declines over time. Vaccine is safe, effective and readily available this season. Doctors' offices, local health departments, and many pharmacies will be offering vaccine. In addition, local health departments are going to offer flu vaccine. The current seasonal flu vaccine is a match for the strains of the virus expected to affect the United States this season. Maryland has no reported flu cases for the 2011-12 season, but influenza is expected to increase in the next few months.

## National Study Center Celebrates 25 Years

On November 21, 2011, the Charles “McC.” Mathias, Jr. National Study Center for Trauma and EMS (NSC) celebrated its 25th anniversary at a seminar entitled, “25 Years of Research: Innovations in Injury Prevention.” The event featured several speakers who have had strong ties to the NSC since its early years.

The speakers for the seminar included Bruce E. Jarrell, MD, FACS, the Honorable Francis X. Kelly, Jr., Colin F. Mackenzie, MD, ChB, Patricia C. Dischinger, PhD, Alan I. Faden, MD, and Thomas M. Scalea, MD, FACS who delivered the keynote presentation.

Many of the speakers shared their stories and memories of the NSC throughout the years. They also highlighted some of the insightful research studies that have been conducted and gave the audience a look into ongoing and future projects. Some notable projects that were discussed at the seminar included the Crash Injury Research and Engineering Network (CIREN) and Crash Outcome Data Evaluation System (CODES) as well as the research currently being conducted in the field of geriatric trauma.

The Charles “McC.” Mathias, Jr. National Study Center for Trauma and EMS was established in 1986 when Dr. R Adams Cowley urged the creation of such a center. A joint resolution from the Maryland General Assembly was sponsored by the Honorable Francis X. Kelly, Jr., and called for the creation of the NSC. The Congressional legislation was then sponsored by Senator Charles “McC.” Mathias and Senator Barbara Mikulski and the National Study Center for Trauma and EMS was born.

Serving as a research arm for the Shock, Trauma and Anesthesiology Research Organized Research Center (STAR-ORC), the R Adams Cowley Shock Trauma Center, and MIEMSS, the NSC is supported by several funding sources, including the U.S. Department of Transportation, the National Institutes of Health, the Robert Wood Johnson Foundation, the Centers for Disease Control and Prevention, as well as major corporations, foundations, and private individuals.

## Riley Foundation Awards 21 Scholarships

On November 9, 2011, the Riley Foundation gave away 21 scholarships to recipients who served their neighborhoods through leadership, community service, and extracurricular activities. The Charlie Riley Community Service Scholarship was given to 12 seniors at various Harford County high schools, and nine fire and EMS volunteers.

Overall, \$24,000 in scholarship money was given out at an awards ceremony held at the Level Volunteer Fire Company fire hall. This year’s scholarship money contributed to over \$100,000 that has been given out by the Riley Foundation in the past six years.

The recipients were each awarded with a \$1,000 scholarship to be used towards higher education with the exception of two recipients who received the grand prize of \$1,500. These grand prize winners were Cynthia Ford of Edgewood High School, and Elizabeth Roberts of the Abingdon Fire Company.

Two more awards were presented at the ceremony that included the Support Award, given to Charles “Bunky” Morkosky, and the Service Award, given to Tony Belcastro.
