Call to Order and Approval of Previous Minutes

The November meeting of the ALS Subcommittee was called to order by Dr. Fillmore at 10:01 a.m. A motion to approve the minutes from the July 2024 meeting (the September 2024 meeting was cancelled) was made by Diane Flint and seconded by Colleen Lull.

Old Business

- Letter to SEMSAC regarding students being charged to precept:
 - Dr. Fillmore has drafted a letter to SEMSAC on behalf of the committee to ensure they are aware of the committee's stance on this potential practice.
 - UMBC has had difficulty obtaining Anne Arundel County as a precepting site for their students for the last couple years. In discussions with the county, they were considering charging for precepting as part of the contract process for allowing students. They are not currently in discussions with the county to contract as a clinical site.
 - Megan Barnum from Anne Arundel county reported that they do not have room for outside students to precept in their jurisdiction because their clinicians do not meet the requirements in COMAR to be able to precept (i.e., have been practicing for at least 2 years).
 - Robby May reported that Howard County is coming up on a similar problem with having enough eligible clinicians to precept and may have to limit outside students as well.
 - No one is aware of anyone currently charging students in Maryland for precepting; however, this is something that is occurring at the national level so that clinical sites can provide additional pay/incentives to preceptors. Charging

for the clinical sites offsets this cost. Colleges are not able to pass this cost onto students easily as a fee due to recent changes in legislation.

• Jurisdictional EMS Programs are not required by COMAR to allow students to precept in the same way that hospital base stations are.
