- NREMT 1<sup>st</sup> attempt pass rates have dropped below National Registry average.

  - o Create an account in National Registry.
  - o Write a letter to National Registry.
  - o Make payment of \$30 to National Registry.
- On initial application, applicant must use legal name.

- Scenario group update
  - o Evaluation workshops were very productive, as a result we will soon be able to have work-shops for training on the new scenarios
