Old Business

- Review of orientation process project continues to move forward. Currently working with IRB to try to move it to next step.
- State Content Courses: Currently in Dr. Chizmar's hands and he is making it a priority to get them reviewed ASAP.
- Dr. Chizmar provided an update to the Law Enforcement assist with force issue. Clinicians were encouraged to continue to seek law enforcement assistance PRN. EMS is not calling to enact an emergency petition, but rather, temporary restraint for a patient who is a danger to themselves or others.

New business Announcements

- COMAR Changes (Ms. Witmer)
 - o Bev discussed the plan to go through and update COMAR regs.
 - o Con Ed 30.04.0507
 - Streamlined
 - Cyndy Wright Johnson: expressed concern that some programs may not be completely covered.
 - o Renewals 30.02.02.07
 - Streamlined and updated
 - Notice "Shall Send" 8 weeks prior
 - Submission should be 2 weeks prior to expiration (as before)
 - EMR renewal change
 - o Reduced hours to 8 hours and require prior 3 years of protocol update in addition.
 - o Con-ed categories required within the 8 hours will be set by state medical director.

- o A MIEMSS approved skills competency verification
- EMT renewal change
 - o 20 hours of continuing education in categories dictated by state medical director.
 - o 3 most recent years of annual EMS protocol updates.
 - o MIEMSS approved skills competency verification
- CRT
 - Meet NCCP Paramedic education hour requirements and complete 3 years of protocol updates
 - o Skills verification
- Paramedic
 - o Active status with current NRP
- EMD
 - o Wordsmithing to regulation
 - o Added 24 hour of EMD con-ed
 - o Removed vendor specific language
- Comments:
 - Craig Smith: reflected on feedback given during BLS meeting. Use competency form as part of the current 24 hour format rather than change the format.
 - Dr. Chizmar stated that there is a possibility/flexibility to continue to use an existing 24 hour training (ie. MFRI course).
 - Bev Witmer responded that the goal is to offer flexibility so jurisdictions can handle their personnel as they best see fit.
 - Robby May voiced that he believed that the rewrite added flexibility to the regulation.

 - o Colleen Finkle asked about having access to the orientation course (under a different name?) for clinicians coming back to field.
 - o Dr. Chizmar was in favor.
 - o David Rice suggested making each module available separately for anyone wishing to take one module or another.
