1. Executive Director search is ongoing. MIEMSS hopes to have a list for the EMS Board within the next two months next 2 months

2. Dr. Alcorta will be retiring effective November 1<sup>st</sup>. Currently looking a contractual representative to learn and transition into the position on November 1<sup>st</sup>.
  3. Fentanyl and Cardizem are some of the medical shortages that the hospitals and EMS are currently facing. A copy of letter was distributed to everyone.
  4. Lactated ringers are improving with Puerto Rico is slowly getting power restored.
  5. Jason Cantera and the Regional Administrators will be meeting with each of the EMS operational programs for implementation of EMEDS Elite. The target date to begin the process is July 1, 2018.
  6. MIEMSS is working on Medical Directors and Quality Assurance Officers having access to CRISP and uploading of jurisdictions service into CRISP. Each jurisdiction, through the Regional office, will receive a Business Associates Agreement that needs to be signed through their legal office.
  7. Over 30 pieces of legislation were introduced this year to help or address the opioid crisis including EMS to use 4 mg/0.1 intranasal. For those who want to put the intranasal administration process on trucks for ALS and BLS may do so.
  8. The Naloxone Leave Behind pilot protocol was approved by the EMS board. The counties that have expressed interest and have funding to allocate for the program are: Allegany, Frederick, St. Mary's, Wicomico and Baltimore City. Interest have been shown from Anne Arundel and Howard counties. Applications are needed before operations begin.
  9. Naloxone compensation process through the Opioid Operation Command Center – Data from the jurisdiction is needed by April 5<sup>th</sup> in order for proper compensation for treat and release.
  10. As of January 1, 2020, the national registry will no longer test new students in the I-99 level in any state. CRTs can maintain existing license. Town Hall meeting will be held on April 17<sup>th</sup> at 1pm in Howard Training Academy.
  11. Learning Management System should be up at the first or second week of April
  12. HB682 that allows EMS to bill for alternate designation, mobile integrated health and treat and release – may end up in summer session. There is another bill that requires reporting by EMS to OD map, run by the High Incident Tracking Administration, to record all overdoses by location and if Narcan was given.
  13. Medical Director Symposium will be held on April 11<sup>th</sup> at the Sykesville Volunteer Fire Department

3. In May and June a reassessment of all hospitals in Maryland will be done on two of the nine performance measures on inter-facility guidelines and inter-facility transfer agreements.

E. MIEMSS Emergency Operations - Randy Linthicum:

1. Last month the Governor issued an Executive Order for active assailant preparedness and response. MIEMSS looking to reinvigorate the active assailant workgroup.

2. CISM training will be held in Washington County in May – a three-day class and will be working with Cecil County to have a class there in June.

3. There will be CISM courses at EMS Care as part of the Pre-Conference: one-day CISM Refresher for existing members and a one-day resiliency course for all responders.

4. A 17 member CISM/Mental Health team was sent to the US Virgin Islands in January and February as part of an EMAC request. The mission was to train and outreach for government employees and first responders who have been impacted and still recovering from the hurricanes. The mission was well received.

5. MIEMSS coordinate with CISM a team for the school staff and teachers at Great Mills High School. An 18 member team was coordinated making up with members from ICISF, Jeff Mitchell, Baltimore County Police Department, Calvert County, Charles County, Carroll, County, Frederick County Public Schools, Montgomery County Fire and Rescue, St. Mary's County and private sector mental health providers.

6. Early planning has begun for the NDMS exercise at BWI tentatively scheduled for Fall 2019.

7. Jeff Huggins will be working with the Region III jurisdictions for participation in the Ambulance Strike Team.

8. Vigilant Guard exercise will be held in Edgewood on May 1<sup>st</sup> through May 7<sup>th</sup> with the full scale exercise on May 8<sup>th</sup> and May 9<sup>th</sup> and a hot wash on May 10<sup>th</sup>. Ambulances are needed for the full exercise. Jurisdictions are asked to any support they can provide.

**EMS Care 2018:** EMS Care 2018 will take place April 25-29, 2018 at the Clarion Resort in Ocean City, MD. Registration is currently open, and courses are beginning to fill up. The full brochure can be found on the MIEMSS website ([www.miemss.org](http://www.miemss.org))

**Triage Tag Days:** Jurisdictions are requested to participate in the quarterly triage tag days to enhance provider familiarity with the tags. Participation continues to increase throughout the region. All region III hospitals should be prepared to receive the tags and may use the EPTS equipment to scan incoming tags if so desired.

**HC Standard Hospital Contact List:** All hospitals are reminded to continue to update their contact numbers in HC Standard. Hospitals can do so by going under their facilities workspace and clicking on the matrix entitled 'Contacts-'Hospital Name'.

**50/50 Matching Grants:** FY2018 applications have been reviewed and approved by regional affairs. Award letters have been distributed, and should be returned if not done so already.

**State Homeland Security Grant Program:** FY2018 applications have been received and are currently being reviewed and prioritized by regional affairs.

**Naloxone EMS Grant:** The FY2018 Phase 1 Naloxone grant has been distributed, and reimbursements are being processed.

**Voluntary Ambulance Inspection Programs:** Spring VAIP's are in the process of being scheduled.

#### **Maryland Region III Health and Medical Coalition Report to the MIEMSS Region III EMS Advisory Council March 28, 2018**

The 2018 triage tag dates will continue quarterly. The next dates are April 3-7. The January compilation revealed the same trends...missing age, vital signs, treatment, and unit number.

There is a Coalition board available to use for health and medical coalition purposes on the state WebEOC system. Access for all health and medical partners is complete.

Allocation of Scarce Resources framework development is complete and has been submitted last summer to MDH for review, approval, and next steps. Continue to await their feedback at this time.

Work has culminated on BP5 HPP projects: a water filtration system training and incident rehab pod demo is pending.

Members of the Coalition are participating in the UASI training and exercise planning workgroup to determine next steps forward.

The Coalition has developed a website. Invites for the member only portal have been sent.

The Coalition continues to work with the MDH Comm Group to move forward with a radio purchase for partners in the Region.

Await additional feedback from MIEMSS on the future of patient tracking. Discussions with CRISP partners have continued. Region is compiling a list of initial hospital participants to be given training and access.

Many lessons learned and areas for improvement were identified from the 2 day JCTAWS (Joint Counterterrorism Awareness Workshop Series). We continue to work on corrective action items.

The UASI Alternate Care Site cache as the USAR warehouse has been relocated to Carroll County and Bayview's storage warehouse. Work continues to sort through the equipment and relocate some. Additional materials for the cache have been received.

At this time, it appears that the ACS will co-exist with the GBMC gym while a new gym is constructed. Await official letter from GBMC officials.

The Coalition is continuing discussion with MSP to ensure that consistent processes are in place regarding healthcare worker expectations for road travel during emergencies.

HPP regional projects for the current budget period are underway. There will be a Regional Surge/Evac Tool Workshop on April 30<sup>th</sup>. Planning is underway for the evacuation exercise as well. Active assailant kits are currently being procured.

The Coalition is collaborating with the new fire and EMS rep at the MCAC.

The group is collaborating with the MDH Ebola Planner to work on training opportunities for regional partners.

Await feedback from MDH as to guidance from CDC for hospital CHEMPACK needed supplies to be stocked since auto injectors have been removed.

The Coalition has begun to discuss concerns regarding PPE expiration and need for replacement with MDH.
