Anna Sierra:

Please welcome Chief Mark Fletcher; he is the new EMS Chief for Caroline County.

Regional Medical Director's Report:

Dr. Chiccone:

Protocol updates from January 16, 2020 meeting:

Pediatric Needle placement – will defer to Cyndy Wright Johnson.

A Direct to Triage protocol was discussed – Handouts were provided showing the difference between Anne Arundel County and Montgomery County's pilot programs.

In the future, a possible statewide protocol may come where you can leave a non-emergent person with the triage nurse in the waiting area. More information to follow...

Dr. Ciotola – There are some fears for the greatest risk of medical errors if not handed off to a nurse. Could we be going down a road that we may regret?

Mary Alice – There have been times where patients were left in the ER when they should not have been. I feel this will be a disservice to some patients.

A discussion started among several council members with concerns regarding patient safety, patient care, and quality assurance if this becomes a protocol. There was also a discussion about when the hospital actually assumes responsibility for the patient.

Dr. Krohmer – Once a patient arrives at the hospital they are the hospitals patient.

Mary Alice – Once a patient is within 250 ft. of a hospital, they are the hospitals patient.

Dr. Chiccone - The rewrite of the protocol book will happen. It will also be available digitally with links to click for details.

Pediatric Medical Director's/EMSC Report:

Summary of Pediatric Protocols

TOR is going to extend to all ages when meeting specific criteria.

Needle placement – the needle decompression site for pediatric patients under 15 years of age will be changed to the second intercostal space at the mid-clavicular line on the anterior chest wall. Placement for patients 15 years and older will remain unchanged. This change is coming out very soon – most likely by the end of the week.

Stars of life – Due date is April 3rd and can be submitted online through the smart sheet. You will be able to attach your forms to your submission. We need everyone to submit a child, at least one from each region.

Week 3 of the EMS Survey - responses are at 52% in Maryland. We have another two months to finish this so please complete the survey. The survey consists of the same questions you answered two years ago. All data is going to Congress to show we are making progress.
