

PEMAC UPDATE –Nov 1, 2023
The CPS & OP Healthcare Project

- Garrett County Emergency Services is the latest agencies to be trained and receive the All-in-One car seats for EMS supervisors' vehicles for non-emergency transport of children. Four of their staff were trained on Oct 27th. Harford County has also expressed interest.
- Helped teach two national CPS Technician certification courses: Oct 12-15 in Sykesville, and Nov 10-12th in St Leonard.
- Gave the 2nd annual "CPS award to an EMS provider for exemplary service" to Daniel Long of the Salisbury Fire Dept. Daniel has been an active volunteer in CPS for about 12 years.
- Three new hospitals joined the car seats for needy families program: Frederick Health—both the MCH and ED units, Medstar Montgomery General (MCH), and Garrett Regional Medical Center (MCH & ED). Tidal Heath has also expressed interest.
- Participated in the National CPS week by helping at a number of car seat checks and exhibits, and having daily CPS messages on MIEMSS social media.
- Held three exhibit on CPS/OP: The Mid-Atlantic Life Safety Conference on Sept 19, Topics in Trauma Conference on Sept 22, and the Wellness Fair at WSSC on Oct 17th.
- Seat checks supported: Baltimore City/Oldtown FD on 9/8 and 10/13, BWMC on 9/20, BelAir MVA on 9/18, Phoenix/Long Green on 9/26, Frederick on 9/28, Mt Washington Pediatric Hospital/Baltimore on 10/20, and Pikesville on 10/24.
- Consulted on several cases regarding safe transport of special needs children and lent or gave some restraints for the clinicians to consider using.
- Received copies of the updated Safe Transport of Children in Ambulances Reference Guide pages on the Ferno and Stryker, and began to distribute these across the state. Working on a new page for the Pedimate +.
