Governor Announces Nearly \$1 Million in State Highway Safety Grants (Office of the Governor). On July 12, Governor Wes Moore announced the distribution of nearly \$1 million in state highway safety grants to 33 organizations and law enforcement agencies, including MIEMSS, for initiatives to promote pedestrian and bicyclist safety and local strategic highway safety plans. 
#### **2023 Maryland Medical Protocols for Emergency Medical Services**

The 2023 Maryland Medical Protocols for Emergency Medical Services took effect on July 1, 2023, and are available online at <a href="https://miemss.org/home/ems-providers/protocols">https://miemss.org/home/ems-providers/protocols</a>. There are multiple evidence-



#### Electronic Maryland EMS Data System (eMEDS®) Updates.


- eMEDS® Updates: Recent eMEDS® updates (EMS & Mobile Integrated Health (MIH)) including:
  - EMS: Validation of Hospital Team Activation/Alert Grid: Better documentation for specialty calls when receiving facility is notified of incoming patient.
  - EMS and MIH: Free-Text field below crew selection for documenting "Other Personnel" on a particular call.
  - EMS: Necessary changes to the run form to accommodate 07/01/23 protocol updates.
  - EMS: "Patient Experiencing Homelessness" and "Veteran Status" added for data collection.
  - MIH: New program type of "Alternate Response".
- eMEDS® Report Count: Number of reports, by quarter, since 2018 (2023 = YTD).



- NEMSIS v3.5 and eMEDS® Release: MIEMSS continues to work on various updates needed to bring our eMEDS® patient care reporting system in compliance with NEMSIS' newest version of 3.5. Updates within the eMEDS® run form, validations, data elements, integrations, and training material will ensure a successful transition for all users.
- Ambulance @ Hospital Dashboard (@HA): MIEMSS continues to work with the remaining two (2) EMSOPs to submit their CAD data to ImageTrend® to populate the @HA Dashboard in near-real time. The final two (2) EMSOPs have an extended projection timeline. In addition to counties submitting their data to the @HA Dashboard, this also improves the "CAD Download" feature that EMS clinicians use to complete their eMEDS® reports in a timely fashion, with information coming directly from the county's CAD/9-1-1 system.



- Mobile Integrated Health (MIH): Since October 2020, MIEMSS has been working with the Statewide EMS Advisory Council's (SEMSAC) MIH subcommittee to implement ImageTrend®'s MIH module. EMSOPs have continued to utilize the MIH module within eMEDS® since Q4-2020. MIEMSS continues to work closely with the MIH subcommittee to review and continue to make improvements based on the subcommittee's recommendations (2023 = YTD).



- eMEDS® Support: eMEDS® support continues to provide a timely response for tickets from EMS clinicians, hospital personnel, and other stakeholders throughout the state. Some common issues include password-resets and login issues, access questions, and report-writer functionality. Emailing the support desk is the preferred method of contact. Each new email received will generate a new ticket for MIEMSS staff to process; users will automatically receive a system-generated email with a unique ticket number upon receipt of the new ticket.

- Quarterly ImageTrend® Releases: MIEMSS and ImageTrend® continue to work to minimize the amount of downtime that occurs during quarterly updates to the eMEDS® site. Each update implements the latest version available from ImageTrend®. All necessary precautions are taken to avoid prolonged outages. However, due to their complexity, some scheduled updates may take up to six (6) hours to complete.

<u>eMEDS®</u> / <u>ESSENCE Integration</u>. In conjunction the Maryland Department of Health (MDH), MIEMSS has developed a near-real time data exchange between eMEDS® and MDH's syndromic surveillance system. This linkage allows MDH to utilize EMS data for the early identification of intentional or natural emerging infectious disease outbreak(s). This effort enables an expedient public health threat and risk

assessment for situational awareness, and ensures prompt applications of public health interventions in the event of a public health emergency. Additionally, MIEMSS, in conjunction with MDH and the Johns Hopkins University Advanced Physics Laboratory, has developed an EMS data module within the State's syndromic surveillance system. This new EMS module is available to other states for the purposes of integrating EMS data with ESSENCE.

Medicaid Supplemental Payment Program. MIEMSS continues to work with the Maryland Department of Health (MDH) on the Medicaid Supplemental Payment Program, which will help rebalance reimbursement to EMS for the unreimbursed costs of providing services to Medicaid patients by calculating and obtaining the appropriate portion of federal reimbursement for these services. The program is open to EMS Board-designated Jurisdictional EMS Operational Programs (JEMSOPs) that 1) are funded directly by public (tax) dollars, 2) bill Medicaid for EMS transports, and 3) document expenses paid with public (tax receipt) funds.

A total of 19 JEMSOPs participated in the program in FY23, including: Allegany County; City of Annapolis; Anne Arundel County; Baltimore City; Baltimore County; Caroline County; Cecil County; Charles County; Dorchester County; Frederick County; Garrett County; Harford County; Howard County; Montgomery County; Town of Ocean City; Prince George's County; Queen Anne's County; City of Salisbury; and Talbot County.

More than 80 percent of all emergency service transports provided to Medicaid members by participating JEMSOPs are potentially eligible for a supplemental payment. This equates to 23 percent of all emergency transports. For the foreseeable future, ESPP will continue to provide annual federal reimbursement for EMS Medicaid costs. JEMSOPs that did not participate in the first few years of the program will have an opportunity to do so in the future.

#### CARDIAC

Cardiac Arrest Steering Committee. The mission of the Cardiac Arrest Steering Committee (CASC) is to improve cardiac arrest survival in all communities in Maryland. CASC held its most recent meeting in August 2023, during which it focused on optimizing subcommittee membership to maximize the contribution of each out-of-hospital link in the chain of survival, thus increasing cardiac arrest survivors in each Maryland community. It also explored multiple ways to celebrate all bystander and public safety clinicians involved in each life saved. CASC's next meeting is scheduled for the first Thursday in October. Attendance may be in-person or virtual.

The next Maryland Resuscitation Academy will be held on Tuesday and Wednesday, October 24-25, 2023.

#### **EMERGENCY MEDICAL SERVICES FOR CHILDREN**

Emergency Medical Services for Children Department (EMS for Children). PEMAC extended time to work on pediatric EMS protocol revisions for 2024 during its most recent business meeting, held July 5, 2023. The summer virtual forums for both Pediatric EMS and Pediatric ED RN Champions focused on Pediatric Readiness in both EMS and ED settings. On July 19, Pediatric EMS Champions met virtually to review the 2023 HRSA Federal EMS Assessment and begin discussion on pediatric recognition for EMS Agencies.

The EMSC Department coordinates four different grant programs:

**The EMSC State Partnership Grant** (federally funded by HRSA/MCHB) focuses on Pediatric Readiness for both EMS agencies and Emergency Departments, including identifying a pediatric champion to provide both advocacy and facilitate communication to all members of the agency/hospital. The EMSC State Partnership Grant is funded for four years, effective 4/1/2023.

- ➤ Hospital Pediatric Readiness: Pediatric ED Nurses interested in moving pediatric readiness forward met with the new EMSC Grant hospital specialist, Mary Ellen Wilson, on 06/28/23 to identify educational topics for the next 18 months.
- ➤ Prehospital Pediatric Readiness: Pediatric EMS Champions met virtually on 07/19/23 to review the 2023 HRSA Federal EMS Assessment and begin discussion on pediatric recognition for EMS Agencies. They will hold their next in-person forum on 10/18/23 at MIEMSS Headquarters in Baltimore.
- FAN Council is continuing to work on the required strategic plan for family involvement in EMSC programming and revising the lecture portion of the Safe Sleep outreach project to include the new recommendations from the American Academy of Pediatrics.
- Pediatric Disaster pre-planning for both EMS and ED is the fourth goal and must focus specifically on including children, youth, and families.

The Child Passenger Safety and Occupant Protection (CPS & OP) Healthcare Project (state-funded through the MHSO), now in its 23<sup>rd</sup> year of funding, continues to provide outreach to health care providers to as well as education and parent educational tools on child passenger safety. June and July education included webinars and in-person training focused on safe transport of children with special health care needs. **The Bike Helmet Safety Project** (state-funded through the MHSO) will start its seventh year of funding providing bike helmets and bike safety education through Safe Kids Coalitions and community partners, Trauma Centers, and Pediatric EMS Champions. The 2023-2024 Bike Safety Grant will focus on encouraging local communities (counties/city-based organizations) to apply for bike safety grants in FY25. The project actively seeks stories of children and adults "Saved by the Helmet" throughout the year. The Safe Kids Maryland state coalition continues to provide prevention information through social media and articles in Maryland EMS News. Many Safe Kids coalitions and both of Maryland's pediatric trauma centers participated in the 2023 International Safe Kids PREV CON, held July 23-26, 2023, at Gaylord Conference Center.
