Promote use of restraints in all seating positions of Ambulance and Fire vehicles and monitoring data on usage. 4. Monitor ambulance safety issues and encourage use of best practices for safety. 5. Reduce the incidence of excessive ambulance speeds and routine use of “lights and sirens”. 6. Continue the ongoing statewide forum for ambulance safety issues and monitor crash involving Ambulances.
