**Old Business**

CRISP Update from Jeff Huggins:

- The name issues have been corrected for the agency name, no longer will say Baltimore County. The historical MD EMS or Baltimore County may/may not change.
- Anyone having issues adding admin's, and have a CRISP agreement on file, MIEMSS (Jeff Huggins) is able to help through their CRISP Liaison.
- Hospitals coming online with the eMeds reports into the HIE. Some are integrated, some are still working through this process. The new portal allows for multiple admins. With the admin rights they can add new users from the tools.
- Matt Burgan - Is there any update on progress for community health reports being uploaded into CRISP? Jeff stated no update, but the topic is on the radar. Montgomery asked about 2019/2020 CRISP conference to create a CRISP LIGHT for the ability to pull up patients through Elite? It is not top of the list but it is a topic of discussion.

- NEMSIS 3.5 upcoming needs done by the end of this calendar year. There is no need to change the pcr platform. The changes that get implemented will have to be mirrored on the CH Module e-disposition 12 will be built out further.
- Avital spoke with a NEMSIS rep while at EMS World and asked why there is no standard for MIH. There are elements in the MIH field that are not included which would be nice to add. Avital will share the contact information with Jason Cantera.

Buprenorphine -

- OSP was presented to the protocol review committee January 11, 2023. Passed with unanimous consent. The goal of the protocol is to connect patients to longitudinal care and if we are able to make them more comfortable. If they are not pharmacologically appropriate with Bup. we can still apply the protocol to Bup. protocol to link them to care. There were minor technical changes but none to the clinical portions. Everyone will have the ability to apply for the OSP equally once MIEMSS is able to finalize. If anyone has any questions about the OSP, reach out to Matt Burgan. Congrats!
