 - 1. No report
- B. State EMS Medical Director Report Dr. Chizmar
 - 1. Harford Memorial, moving to Aberdeen in February 2024, will retain their behavioral health unit and expand there.
 - 2. Franklin Square is now a comprehensive stroke center.
 - 3. The last Protocol Review Committee was held for 2023 last week. Several changes will include: persistent data protocol, vector change to fibrillation, double sequential fibrillation, clarification to burn and carbon monoxide protocols, MIH protocol modifications several jurisdictions to do blood draws

and acquire 12-lead ECGs, use of language line for interpreter service – under general patient care protocol, ketamine infusions for RSI jurisdictions that have ventilators and infusion pumps, patients who suffer from overdose for recovery resources. The new proposals will go to the EMS Board in December for approval.

- 4. Four jurisdictions who have signed up for the buprenorphine optional supplemental for the MIH jurisdictions. There are various stages of development for Baltimore City, Baltimore, Frederick and Montgomery counties.
- 5. MIEMSS is working with QA/QI Officers, PSAP and 911 Center Managers on recording times for CPR.
- 6. Cardiac arrest survival rate is around 33%. Dr. Chizmar will work with the council and cardiac arrest steering committee to help raise the survival rate.
