 - a. Dr. Chizmar, State Medical Director:
 - i. CHATS Alert System;
 - 1. Poll was sent 70/30 in favor of suspension of colors system
 - a. Supportive of replacing system instead of just shutting off.
 - b. Will wait until EDAS is operational before cutting off CHATS

- i. Not removing trauma bypass, re-route and code blue
- ii. Thank you everyone for their vigilance in the hospitals and in EMS.
 - 1. Adult hospitalizations have dropped to just below 3K for the first time in a while.
- iii. Some of our programs to mitigate load have yielded success
 - 1. Pandemic triage protocol
 - a. 105 patients screened in the first 19 days of 2022 with 74% able to remain at home.
 - i. Less than 3% require ED visits within 24 hours "Bounce back"
 - b. Couple with guidance on where to find tests will help reduce load on the ED.
 - 2. Direct to Triage:
 - a. Most EMSOPs are participating.
 - i. 130-200 patients per week statewide are being transported directly to triage. Good work.

3. Public notices

- a. All prior provisional EMTs that were to expire on 2/11 have been extended to 5/11. Hope that they convert their provisional to full license
- b. Added provision for new provisional EMT until November of this year.
- c. All who were to expire on 12/31/21 have been extended to 1/30/22
- d. CRT, EMT & paramedics as vaccinators. Back in play
- e. EMTs field internships requirement prior to cognitive test has been removed. Order has been altered. They still have to complete one but the

4. Protocol additions

- a. Extraglottic airways expanding
 - i. King, Air Gel, LMA, IQ
- b. Medication additions
 - i. TXA 1g dose
 - ii. Troperidol 2.5mg
- c. Office of Clinician services has done a ton of work to put education online.
 - All 10 hours of state contact for ALS are available online
 - ii. New content launching in April.
 - iii. BLS Abuterol and Manual Draw epinephrine are available in the online training center
 - iv. QA/QI officer training course is now online, Congrats Dr. Pint Peralta
- d. MHCARS Maryland Commercial Ambulance Resource system
 - Hospitals can post patients that need commercial transport where their contracted service is not available.
 - ii. Medicaid has strict rules about using contracted vendors. Working through it.
 - iii. Goal is to decompress the hospitals as much as possible
- e. SB 70: Treatment of Service dogs
 - Extends immunity to clinicians to provide care or decline
 - ii. Included language to provide additional training for clinicians for Tx of K9s
- f. Upcoming conferences going online:
 - i. Winterfest and Miltonberger

g. Looming drug shortages

- i. Epinephrine & Pre-filled syringes. Look for a guidance memo on how to dilute 1:1000 to 1:10,000
 - Tough decisions to go to alternate suppliers for pull from low usage units due to supply shortages.

ii. Questions:

- Dr. Baker: Does MHCARS include level of care?
 - a. Dr. C. Yes. Very basic system that doesn't' share PHI.
 - System is for people who have been languishing for a long time and there's no viable transport for the next few hours. No firm guidance
- 2. Dr. Luis Pinet Peralta: Behavioral Health patients, MHA: Is this something that will help with that or is that handled elsewhere?
 - a. Behavioral health is being handled by Sheppard-Pratt. Not something we're directly involved in.
 - b. Dr. Stone: is there anything that prohibits using the MHCARS for BH patients? Dr. C. No but the hospitals have to sort out reimbursement and navigating Medicaid.

 - i. CHATS replacement
 - 1. New Advisory System to replace colors
 - 2. In late construction phase

 - 1. Drop times: State is reminding EMSOPs that the viral pandemic protocol is still available to work with qualified patients to stay home with viral illness. It's a low hanging fruit solution for patients who may not necessitate a visit to the ED.
 - a. Baltimore City is reporting low acuity patients on fire apparatus due to lack of EMS transport resources. Is this a "canary in a coal mine" for high usage and low resource situations state wide?
 - b. Calvert EMS: Has considered use of staff to monitor patients in ED, waiting for beds to release units back to

service. Curious to hear what their data is from this program

 Seeing a small improvement. Hoping to continue. Have instituted a Multi-patient management General Order to assist with units held at a hospital:



3. EMS-800

- a) Perform a system assessment and make recommendations to the Duty Chief.
- Report to hospitals with excessive EMS units to facilitate transfer of care and release of units.
 - Have EMS transport units complete a short form to reduce hospital turnaround time.
- Multi-Patient Management Transfer multiple BLS patients to a single EMS unit at a receiving facility.
 - (1) Maximum 3 patients to one EMS crew.
 - (2) Short form will be completed by the transporting unit.
 - (3) Once a patient is off-loaded, the transport unit will immediately return to service.
- d) Coordinate with the Northern and Southern EMS Duty Officers and Battalion Chiefs.

4. EMS Provider

- a) Complete a short form to reduce turnaround time at the hospital.
- b) Multi-Patient Management Transfer multiple BLS patients to a single EMS unit at a receiving facility, only in consultation with an EMS Duty Officer.
 - (1) Maximum 3 patients to one EMS crew.
 - (2) Short form will be completed by the transporting unit.
 - (3) Once a patient is off loaded, the transport unit will immediately return to service.
- Montgomery County Fire/Rescue Dr. Stone:
 - Personnel Changes QA: In the process of filling the position. Captain Burns from the QI office has promoted to Battalion chief. Still helping in process of transition.
 - Have had success with an EMS destination officer in the last surge and have put it back in service for this surge.

• Calvert County EMS -

- Monitor at Calvert Health: Stephanie Cleaveland, has had a significant decrease in drop times by having a dedicated crew.
- Ken Miller: Struggling with Offload times like other jurisdictions. Worked with Stephanie put an EMS & ALS clinician in the hospital during surge. 22% reduction in hold time and average drops are at 30%. "Continuation of Care Monitoring Policy" Policy is set up to be activated and deactivated as needed. Cannot take patient transfer from out of county unit. Looking forward to seeing its benefit.
- Heather Howes: Reminding neighboring counties. Calvert's CAD does not feed to @HA so it shows no units at Calvert Health when there are. Richardson: working on getting the cad data to get
