- a. Update on FY 2023 Grants
 - i. The following companies/jurisdictions have not been reimbursed:
 - 1. Region I: Baltimore Pike VFC and Potomac Fire Company #2 Inc.
 - 2. Region II: United Steam Fire Engine Co, Carroll Manor Fire Company and Washington County DES. Dave Chisholm has submitted a request for reimbursement for Washington County.
 - 3. Region III: Anne Arundel County FD, Baltimore City FD, Carroll County Department of Fire and EMS, Howard County Fire and Rescue and Harford County.
