- a. Bloomington VFC an updated agreement was received on February 6th; awaiting signatures. Company has received a purchase order from their original signed agreement.

 - a. Everyone has received their purchase orders.

 - a. Baltimore County Fire Department A motion was made by Eric Smothers and Christopher Truitt and was approved to give Baltimore County three weeks to submit the signed agreement to MIEMSS. If the agreement is not received by March 29th, the \$42,587.25 awarded will be re-allocated.
