I. Call to order

II. Cardiac Devices Grants

- a. Update on FY 2023 Grants
 - i. The following companies and jurisdictions have not received their equipment and/or submitted paperwork for their reimbursements:
 - 1. Region I: Baltimore Pike VFC and Potomac Fire Co. #2 Inc. Baltimore Pike VFC will not be able to use their funds and they cannot be reallocated because the funds were from FY 2023.
 - 2. Region II: United Steam Fire Engine Co. #3 have received their equipment and Carroll Manor Fire Co.
 - 3. Region III: Baltimore City FD and Howard County Fire and Rescue
 - 4. Region IV: Dorchester County ES-EMS, Fruitland Fire Co, Cecil County DES, Princess Anne VFC Inc., Charleston Fire Co., Hacks Point VFC, Sharpton FD, Lakes & Straits FC and Church Creek VFC
 - 5. Region V: All companies have been reimbursed
 - ii. The grants that are not reimbursed by midnight on June 30, 2024, the funding will not be available. Staff has been instructed to follow up with the companies to ensure they are able to submit their reimbursements.

b. Update on FY 2024 Grants

i. All companies have received their purchase orders. Reimbursements have been processed for Libertytown VFD and Leitersburg VFC (Region II) and Kent Island VFD (Region IV).

ii. Redistribute excess funds

1. \$3,353.00 will be redistributed due to Ridge FRS, Inc cancelling their grant and Bloomington VFC had to update their funding costs. (Region II), Annapolis FD (Region III) and Kent County Office of Emergency Services (Region IV). Each awardee will granted \$1,117.66.
