- iv. Region IV: Sharptown VFD Reimbursement request was received but the award agency changed their mailing address. The reimbursement will come from the FY 2026 funds. The Comptroller's Office will not authorize payment until the W-9 is received. The funds are still available for FY 2025 if the W-9 is completed sooner. Community Fire Company of Rising Sun is also outstanding.
